YOU ACKNOWLEDGE THAT YOUR CHILD IS VOLUNTARILY PARTICIPATING IN THE ACTIVITIES AND THAT YOU HAVE KNOWLEDGE OF THE DANGER INVOLVED AND HEREBY AGREE, ON BEHALF OF YOURSELF AND YOUR CHILD, TO ACCEPT AND ASSUME ANY AND ALL RISKS OF INJURY, DEATH, OR PROPERTY DAMAGE, WHETHER CAUSED BY THE NEGLIGENCE OF GIANT EAGLE, FIELD TRIP FACTORY, OR OTHERWISE.

You hereby expressly waive and release any and all claims, now known or hereafter known in any jurisdiction throughout the world, against Giant Eagle, Inc. and Field Trip Factory, and each of their respective officers, directors, employees, agents, affiliates, partners, members, successors, and assigns (collectively, "Releasees"), on account of injury, death, or property damage arising out of or attributable to your child in connection with the field trip, whether arising out of the negligence of Giant Eagle Inc., Field Trip Factory, or any Releasees or otherwise. You covenant not to make or bring any such claim against Giant Eagle Inc., Field Trip Factory, or any other Releasee, and forever release and discharge Giant Eagle Inc., Field Trip Factory, and all other Releasees from liability under such claims. You shall defend, indemnify, and hold harmless Giant Eagle Inc., Field Trip Factory, and all other Releasees against any and all losses, damages, liabilities, deficiencies, claims, actions, judgments, settlements, interest, awards, penalties, fines, costs, or expenses of whatever kind, including attorney fees, other fees and the costs of enforcing any right to indemnification under this permissions slip, and the cost of pursuing any insurance providers, arising out or resulting from any claim of a third party related to the field trip.
